Minutes: Board Meeting, May 2, 2007

President Ed Barrios called the meeting to order at 3:01 p.m.

Financial: Balance as of 05/03/07: \$3338.47.

The budget for 2007 was presented. Jerry explained that certain assumptions were made in preparing the budget. They are:

*Intern class

- Revenues and expenses based on full class of 25. Breakeven is somewhere between 15 and 20 participants.
- Refund of \$45 will be accrued for 2008 dispersal
 - **★We will be able to collect dues from about 80% of COT members. So far only 73 of ~ 100** members have paid 2007 dues.
 - *We will collect \$250 of 2008 dues before the end of 2007.
 - **★We will donate the 2006 State Meeting \$150 poster prize money to a partner.**
 - *****General expenses were based on 2006 actual and inflated by about 5%.
 - #Have set a budget of \$100 for social expenses.

Please see addendum 1A and 1B for copies of the full budgets.

There are still a number of people who have not paid their dues. The board discussed the importance of members paying dues to show their commitment to the organization.

Three members requested their names be moved to the inactive list: Tommy Holt, Paul Webb, and Susan Webb.

Outreach: Ed reported for Marty. The MN display had been set up at Family Day, Sea Center Texas, Earth Day, Brazos Bend and Brazosport Mall. Marty also made a presentation to the Alvin Kiwanis Club. Twenty four people have indicated an interest in the fall classes; 21 are interested in Saturday classes, while 12 indicated that they can do the Wednesday classes. Two people have already paid to take the class, while six others have called Sandra and made inquiries. Information has been sent to these people. There are other prospects who have indicated that they plan to take the fall class. Laura has been calling or e-mailing those who signed the sheets at the Mall, Sea Center or Brazos Bend.

The pros and cons of having Saturday classes were discussed.

The option of having Saturday class will remain under consideration by the board in hopes of working out some of the problems.

TMN-COT Partner List: Certain correspondence with The Friends of the Brazoria County Refuges indicated that the organization was a partner with COT. Clarification was requested by Ed. The COT is a partner with the Mid-Coast Refuge System, USFWS, but not the Friends organization.

Social Activity for June: At the regional meeting in February, the Bay Area Chapter emphasized the importance of having "food--fun--friendship" at their chapter meetings. One of the ways they accomplish this is to have "pot luck" suppers at some of their meetings. At the March board meeting this was discussed and the board felt that this would encourage social interaction between members and encourage participation other than strictly volunteer opportunities. Bay Area MN also have a quarterly awards presentation at this time.

The board proposes to begin this type of practice at the June meeting and will poll the membership at the May general meeting for input.
