# TMN-COT BOARD MEETING <br> Wednesday July 3, 2013 <br> AgriLIFE ${ }^{\oplus}$ Conference Room, Angleton, Texas 

Attendees: Ed Barrios, Barbara Burkhardt, Marty Cornell, Jerry Eppner, Mary Helen Israel, Jerry Krampota, Ruby Lewis, John Marshall, Neal McLain, Roy Morgan, Tom Morris, Mike Mullins, Peggy Romfh, and Pete Romfh.

President Mike Mullins called the meeting to order at 10:01 am.
Ed Barrios moved and Jerry Eppner seconded the motion to approve the minutes of the June, 2013 board meeting, as amended with email input. This motion passed with no dissent.

Secretary Marty Cornell reviewed the action items pending from the June board meeting:

- The submission to the general membership by Mike Mullins of the proposed change, to specify the timing of the appointment of a financial audit committee, in the chapter's Policy and Procedures Guidelines (P\&P) remains on hold pending the accumulation of other proposed P\&P changes.
- It was decided to forgo contract printing of card rack brochures, opting instead to use trifold brochures printed at the AgriLIFE office.
- Ed Barrios intends, by the August board meeting, to amend the P\&P appendices to insert the Texas Parks and Wildlife Department (TPWD) volunteer insurance coverage.
- Ed Barrios intends, by the August board meeting, to change the P\&P section on voting privileges of board members to be consistent with the state TMN Bylaws Template, Article VI, item 6.
- Before the August $7^{\text {th }}$ board meeting, Ed Barrios will provide the board members with a summary of pending and proposed changes to the COT P\&P, listing separately those changes that do and do not require approval by the general membership.
- At the August $7^{\text {th }}$ board meeting, Ed Johnson will submit a budget for the 2014 intern training classes.
- At the June $12^{\text {th }}$ general meeting, Ed Johnson held a silent auction of excess TMN shirts. The results were not reported.
- Barbara Burkhardt recruited Roy Morgan to be the new training chair, with help from assistants Kirby Rapstein, Howard Allen, and Barbara Burkhardt. It was mentioned that Barbara wrote proposed job descriptions for the training chair and for assistant training chairs, and that these job descriptions could be added to the P\&P. These documents were not available at this board meeting.

- At the August $7^{\text {th }}$ board meeting, the ad hoc committee of Jerry Eppner, Ed Johnson, Tom Morris, Pete Romfh, and Dick Schaffhausen will present a proposed protocol for "Members-in-Training" to accrue VT and AT.
- Pete Romfh considered the U.S. Fish and Wildlife Service Image Release document in his draft of the COT photo publication policy, which will be presented to the board at the August $7^{\text {th }}$ meeting.

John Marshall articulated the following financial activity over the past month; income consisted of the sale of one TMN-COT shirt for $\$ 30.00$ and $\$ .93$ interest.

Program Chair Peggy Romfh reminded the board that the AT topics for the next two general meeting will be:
$\checkmark$ July $10^{\text {th }}$; Brittney Zepeda of Sea Center Texas will cover mollusks and lead the members in squid dissection.
$\checkmark$ August $14^{\text {th }}$; Tasha Metz of TAMU-Galveston will discuss sea turtles.

Facebook Editor. Mike Mullins announced that Dick Schaffhausen has agreed to assume the role of editor of the chapter's Facebook page, replacing Angelika Fuller, who is moving out of Brazoria County.

New Member Board Position. With Roger Allen's withdrawal as a participant on the COT board, new member Chris Kneupper will be invited by Mike Mulling to serve.

Outreach chair Ruby Lewis reported on the six activities highlighted in green in the following table. For the first half of 2013, COT members have served 19,606 people. Ruby was quite pleased with the increase in attendance at the Science day at the Lake Jackson Historical Society, 359 people this year, up from 50 attendees last year. Ed Barrios will provide the number of COT volunteers and their volunteer hours for the Camp Mohawk summer camp.

Pete was also asked to check with TMN state to see if a photo release form exists, and if not, to develop a photo release form that will be part of the Photo Publication Policy as well as inclusion in the forms section $\mathrm{P} \& \mathrm{P}$ addendum section. Upon adoption by the board, Mike Mullins will send a copy of the COT Photo Publication Policy to Michelle Haggerty of TMN-state. This policy will be part of the P\&P guidelines.

## Miscellaneous:

- Peggy Romfh noted that the state TMN organization is calling for chapters to present volunteer service projects at the state TMN convention in the fall. The ensuing discussion noted that the development of our photo gallery site could be a topic of interest. The decision to pursue this idea was deferred to Peggy, should she decide to attend the state meeting.
- Via email, Barbara Burkhardt asked the board to consider moving our training classes to the fall. It was decided that this fall was too soon to recruit and organize a class.
- Ed Barrios is to draft a Records Retention guideline, based on the outcome of the records retention committee meetings, for approval by the COT board.
- Mike Mullins will present the TPWD Volunteer Insurance Coverage document to the general membership at the July $10^{\text {th }}$ general membership meeting.
