Members were given a handout of plants that attract Eastern bluebirds either for their berries or the insects the plants attract.

SHARE.txblues.org – program can be downloaded and saved, edited and shared

There are three bluebird species: Mountain bluebird, Western bluebird, Eastern bluebird. The bluebirds in Brazoria County are Eastern bluebirds. Our Eastern bluebirds are cavity-nesting birds.

Members were encouraged to place nesting boxes in areas that could be monitored at least twice a week and to join Nestwatch.org and enter observations once bluebirds have nested.

Bluebirds' diet is 75% insects, 25% fruit. Mealworms can be ordered from thenaturesway.com.

Pauline recommended a book titled <u>Bringing Nature Home</u> by Douglas Tallamy about how native plants sustain wildlife in our gardens.
