# **Board Presentation:**

**Mary Carol Edwards**, Texas Coastal Watershed Program gave a presentation to the Board about four active storm water wetlands projects:

- Exploration Green Park in Clear Lake City
- Pearland Nature Center at in Pearland at John Hargrove Environmental Complex, 4800 Magnolia Rd. (Brazoria County)
- Kost Pond Storm Water Detention Basin in Alvin at Kost Road at South St. (Brazoria County)
- Floating Wetlands at Clear Creek ISD Education Village

She is soliciting support from TMN-COT for plant and seed collection, plant propagation, wetlands and prairie planting, flora and fauna surveys (especially bird counts) and mentoring of volunteers and students.

The Board expressed support of these projects, especially those in Brazoria County, and will follow up with her to put a project partnership in place.
