- Treasurer's Report: In lieu of the recent passing of Treasurer, Gerald Forrest, Dave proposed that Don Sabathier assume those responsibilities. Roy Morgan moved, seconded by Ed Barrios, that Don Sabathier be appointed to serve the remainder of 2015 as treasurer. The motion carried.
- Volunteer Management System Update VMS Transition Committee: Dave Brandes reported that those responsible for the implementation and management of the new system have been trained. He showed an overhead of the implementation of the VMS as well as a handout of the new "VMS Federal Reporting Codes and TMN-COT Project/Opportunity Codes." Any additions that need to be made will be submitted to Pete and Peggy Romfh.
- **Media Library Move: Neal McLain** reported that the move to the Volunteer Room has been postponed for another month due to a delay in moving shelving.
- Newsletter Editing, Neal McLain, Publications Coordinator. The duties and responsibilities of the Publications Coordinator were discussed. It was determined by the board that duties include overall responsibility and authority over the layout for publication of the newsletter.

Leo Novak, Vice President/Programs, reported that Robert K. Webster, Ph.D. Candidate and Research Assistant at Texas A&M University will present the program, "The Sargassum Early Advisory System (SEAS) at the August general meeting. Ed Barrios will present the quiz on "Insects." Kenneth Nugent, President of the Brazoria County Beekeeper Association will present the program on September 9th. There will not be a quiz in September.

Jerry Eppner, Membership Coordinator, will send out a note to the membership requesting that timesheets be turned in. Currently there are only seventy timesheets that have been received.

Ed Barrios, State Representative, discussed various topics in the new state Volunteer Management System that specifically relate to the Policies and Procedures of the chapter. The goal is to get all documents completed and sent to the board by the end of the month.

Roy Morgan, Training Coordinator, indicated that he will contact members interested in filling his position by September. He has begun to schedule speakers for 2016. Intern training begins in January. Last year, there were fourteen training topics. He also announced that the minimum age for membership is eighteen.
