In addition, Lou Golish announced an upcoming native plant planting at Surfside Beach at a date to be announced.

Advanced Training: Larry Ruhr shared the following upcoming AT events (see calendar for more information) and asked to be contacted regarding additional AT opportunities.

- Buff-Breasted Sandpiper Surveys—April 13 is the last training date
- Turtle Patrol Detection Training—April 26 at San Bernard NWR is the last date (annual training required and up to two hours AT given)
- Quintana Park Beach Safari—May 1, 2 and 8 are training dates.

Larry also presented information regarding a new TMN Specialist Certification opportunity, the Texas Waters Specialist. The goal of the certification program is to "develop a corps of well-informed volunteer specialists who provide education, outreach, and service dedicated to the beneficial management of aquatic resources and aquatic habitats" in State of Texas communities.

Certification requirements include:

- Reading the required curriculum in the book, Texas Waters—Exploring Water and Watersheds
- Eight hours of approved AT training relative to water and watersheds
- Initial 10 hours of VT service relative to Texas waters and then 10 additional hours each year for recertification.

Larry indicated that more information would be available in the May chapter newsletter; in the meantime, interested members can contact him.
