### Media:

**Neal McLain, Media Coordinator,** reported that the location for the library has not been finalized so discussion is suspended until January.

### **Programs Update/Gallery:**

**Peggy Romfh, Vice-President,** informed the Board that the January General Meeting program is a mixed bag of environmental issues titled "Protecting the Environment." Stephen Scalise, Coastal and East Texas Outreach Coordinator for the Take Care of Texas Program, a part of the Texas Commission on Environmental Quality, will be our guest speaker. His presentation is titled "Take Care of Texas." Besides Stephen Scalise, there will be additional short





presentations on Texas Beach Clean-up programs and Recycling. Discussions will follow on how TMN-COT members might incorporate these concepts into our educational programs.

**Photo Gallery:** Peggy shared that the photo gallery has now reached 45,000 views and has a total of 850 identified species to date.

# Outreach:

Ruby Lewis, Outreach Coordinator, reported on two recent events:

- November 22 / 23 Festival of Lights in Lake Jackson involved 12 volunteers with approximately 3000 participants. Ruby will request a bigger site for TMN-COT next year and will negotiate a more centrally located site.
- KBR Kids Day required 31 volunteers with 6000 participants.

The motion carried by unanimous voice vote. The current action item is adjusted to reflect the new motion.
