The Flower Garden Banks National Marine Sanctuary is sponsoring a "Name a New Manta" Contest. Applications are available at the Brazoria County Library. A brochure was provided.

"A Taste for Nature 2015": Marty Cornell reported that 188 guests attend the ATFN 2015 event and that \$52,000 had been raised for Friends of Brazoria Wildlife Refuges to support the development of the Bobcat Woods Trail at the San Bernard National Wildlife Refuge. Requests will be sent for volunteers to help rebuild and extend the boardwalk at the San Bernard refuge.

"Restoring the San Jacinto Battleground to 1836: Challenges and Achievements," was presented by Boyd R. Harris, Lead Interpreter, San Jacinto Battleground State Historic Site. The historical perspective of the battlefield was presented along with the mission to restore the battlefield park to its 1836 appearance. Working alongside Texas Master Naturalists, the Interpretation Staff at San Jacinto is planning a variety of historical and natural programming for the public in the upcoming years.
