**Migration Celebration:** Ed Barrios, head of the Migration Celebration committee, provided historical data on the event including number of volunteers and attendees. He appealed to members to volunteer as much as possible. This year's volunteer coordinator, Lisa Myers, noted that sign-up sheets were available at the meeting and she would be reaching out to members via e-mail as well. She added that John O'Connell would need at least six volunteers on Saturday and five on Sunday for the Stream Trailer.

**Water Fairs:** John O'Connell announced that volunteers would be needed for Water Fairs at three schools (and possibly a March 28 date in Pearland) and at Migration Celebration. Water Fairs, he said, consists of five stations, and the next training will be held on March 21 from 2 p.m. to 4 p.m. Members who have been trained were welcome to attend the training as a refresher.
