Jackie Hicks announced Brew on the Bayou, a major fundraiser for GCBO. Volunteers are needed for the March 23 event that runs from 4 p.m. to 8 p.m. Tricia Patton is the GCBO contact and tickets are \$20 each in advance and \$25 at the door.

**Nurdle Patrol—Oron Atkins** showed a short PowerPoint presentation on Nurdle Patrol. It is a new, citizen-science project begun last November by the Mission Aransas National Estuarine Research Reserve (<a href="www.MissionAransas.org">www.MissionAransas.org</a>, <a href="mailto:jace@utexas.edu">jace@utexas.edu</a>) to collect data on how many nurdles (industrial plastic pellets that escape into the environment through mismanaged handling activities) are on Texas Gulf Coast beaches and where they are located. Since surveying one spot on the beach takes relatively little time, Peggy Romfh suggested that volunteers enter a minimum VT time of 30 minutes.

**Brazoria County Big Tree Registry—Chris Kneupper** indicated that a webpage for the project was rolling out today and could be accessed via a link on the COT website. The project webpage contains various links to champion trees, historical trees, iNaturalist, etc.
